Longstanton Parish Council Annual Report 2019/20

This report comes to you following my first year as Chairman of Longstanton Parish Council.

We have achieved a lot this year and much of what the Parish Council does sadly goes un-noticed. Due to the rather strange year we've had so far, unfortunately some of the things we hoped to achieve remain on our 'to do' list, but we'll get back to them as soon as conditions allow. I hope the information below provides some insight to the work we have been undertaking on your behalf.

Finance

The precept request remained at £98,869 for 2019/20. Due to the increase in the number of dwellings on Northstowe, this saw a decrease of 21.87% on the average Band D property precept contribution. We continue to collect precept from Northstowe residents which will be returned to any council set up in Northstowe following the Community Governance Review currently being undertaken.

Trees

After years of trying we finally received permission, and some funding, from Cambridgeshire County Council Highways to plant some trees on Home Farm Road. 45 trees have been planted and now in leaf are helping to create a lovely entry into the village from the A14 end. We continue to look for areas where we can plant more trees. Another 5 were planted on the Village Green along with 2 trees from SCDC.

Spice Museum

Permission was gained from Steve Coogan (Alan Partridge) for 'Longstanton Spice Museum' to be created in the village. Work is ongoing to refurbish and create the 'museum' in an old K6 phone box.

Other notable work in 19/20

- Worked with sports groups and the community to upgrade the changing rooms at the Pavilion.
- Worked with SCDC on the ongoing Community Governance Review for the future governance of Longstanton and Northstowe.
- Managed to get SCDC to agree to fund a water 'expert' to look into the potential dewatering of the gravel seam which runs through the parish and the affect it has had on the natural landscape.
- Continue to provide events for the village with the help of the community including: annual litter pick, Open Air Cinema, Remembrance Day Parade and the Christmas Lights Switch On.
- Introduction of the 'Sustainability Working Group' who are working towards 'Plastic Free Longstanton and *Northstowe*', introduced Terracycle (3 programmes) to the village and other projects to follow.
- Community response to Covid-19.

Longstanton Parish Council Income and Expenditure Account for the year ended 31st March 2020 Financial Summary


The majority of the income to the parish council comes in the form of the Precept (this is collected by South Cambridgeshire District Council and is included in the Council Tax payments) and receipt of S106* money for Public Open Spaces (POS) and Community Facilities.

Earmarked Reserves were set up by Longstanton Parish Council in 2018 cover earmarked funds for village projects, Home Farm, S106, Pavilion, Youth Council and Elections.

COUNCILLORS

11 unpaid elected/co-opted) Councillors who 'hold a seat in public office' attending at least 11 meetings per year (held second Monday of the month except August.

PARISH CLERK

The only employed member of staff, Libby White is a qualified Clerk having completed Level 4 Certificate in Higher Education in Community Governance and working towards Level 5, Foundation Degree.

CHARITIES

Longstanton Parish Council is sole trustee of Longstanton Village Hall and Recreation Ground and the Gravel Pit charities.

VILLAGE EVENTS

Co-ordinated various community events including Annual Litter Pick, Open Air Cinema including the Big Weekend, Remembrance Sunday Parade and Christmas Lights Switch On.

GRANTS

Awarded a total of £2,712 in donations/grants to First Responders, Bobby Scheme, Friends of St Michaels, British Legion Poppy Appeal, Senior Citizens' Christmas Lunch and Magpas.

GENERAL POWER OF COMPETENCE

Longstanton Parish Council adopted the General Power of Competence to gain wider powers to deliver more for Longstanton.

PLAYGROUNDS AND OPEN SPACES We maintained the

Recreation Ground and two equipped areas of play on Duddle Drive.

PRECEPT

Though an increase in precept to £99,430 for 2020/21 this means a decrease of £7.59 for the average Band D property compared to the equivalent charge for 2019/20.

COMMITTEES/WORKING GROUPS

Councillors serve on a variety of committees and working groups including: Employment Committee, Finance Committee, Pavilion Working Group (WG), Sustainability WG and Village Events WG.

PLANNING

Over the year, 92 planning applications have been considered at full council or planning meetings. 43 of these were for Northstowe.



SUPPORTING LOCAL GROUPS

We continue to support Music Madness, Little Leprechauns, Rainbow Baby Club and Longstanton & District Heritage Society in costs for hall hire.

CEMETERY

Hatton Road Cemetery is managed and maintained by us. There was one burial in the cemetery during the year.
