## 20-21/239 PLANNING MATTERS

### **Planning Matters for comment**

- a) [20/02453/S73](#) – Variation of Condition 7 (Traffic Management Plan) pursuant to planning permission S0/0277/19/FL to reflect the proposals in the Traffic Management Plan to substitute the current wording in Condition 7 with 'The development hereby permitted shall be carried out in accordance with the Traffic management Plan prepared by SLR Consulting, Version Final\_1 and dated December 2019' (resubmission of 20/01547/S73).

Cllr Street joined the meeting at 7:38pm.

It was **proposed** by Cllr delaMare-Lyon, seconded by Cllr Burns and **RESOLVED** by a unanimous vote that there remains concern remains around road and traffic safety. It is not understood whether the planning committee will be discussing this at their meeting on 12<sup>th</sup> May. It was agreed that should the application be resubmitted to the Planning Committee on 12<sup>th</sup> May, representation would be from Cllr Brash-Hall if between 10-3pm, or Cllr Street after 3pm.

- b) To reconsider the following application following additional information received. [20/05101/FUL](#) – erection of chalet bungalow with garage and associated infrastructure at Land at the Retreat, Fewes Lane, Longstanton, CB24 3DP.

After a brief discussion, it was **proposed** by Cllr delaMare-Lyon, seconded by Cllr Street and **RESOLVED** by a unanimous vote that to clarify statements made in February. Cllrs continue to support the application and it was noted that many of the original material planning considerations which had been concerns at previous meetings had been addressed. It was reiterated that members continue to be worried about highway safety, and that this would need to be monitored with close communication between the parish council, planning authority and the developers.
